Australian Potash Limited (ASX: APC) (**APC** or the **Company**) advises that it has issued 135,715 fully paid ordinary shares (**Ordinary Shares**) on the conversion of 135,715 listed options (APCOB) (**Listed Options**), with an exercise price of \$0.12 each. The securities are part of a class of securities quoted on the Australian Securities Exchange.
