The Company entered voluntary administration on 6 December 2023 and, following creditors' approval for a Deed of Company Arrangement, exited voluntary administration on 1 February 2024. On 2 February 2024 a capital raising targeting up to \$6million was announced. The capital raising is expected to be partially underwritten and completed during March 2024 and will provide the Company with an appropriate level of funding to progress its objectives.
