AUSTRALIAN POTASH LIMITED CONVERSION OF LISTED OPTIONS AND APPENDIX 2A

Australian Potash Limited (ASX: APC) (**APC** or the **Company**) advises that it has issued 2,194,507 fully paid ordinary shares (**Ordinary Shares**) on the conversion of 2,194,507 listed options (APCOB) (**Listed Options**), with an exercise price of \$0.12 each. The securities are part of a class of securities quoted on the Australian Securities Exchange.

Notice under Section 708A

The Company gives this notice pursuant to Section 708A(5)(e) of the Corporations Act, that 2,194,507 Ordinary Shares were issued on conversion of the Listed Options.
