Appointment of Chair

Australian Potash Limited (the **Company**; ASX: APC) is pleased to advise the appointment of Dr Natalia Streltsova as Non-Executive Chair of the Company. Dr Streltsova replaces Mr Jim Walker who has submitted his resignation as a director, due to other increasing corporate commitments.

The Board formally appointed Dr Streltsova as a director at a meeting following the Company's annual general meeting on 15 December 2021, and she was elected unopposed to the role of Chair at that time.
